220. Planning Applications

- a) P20/01276/F – 23 Charnhill Ridge Mangotsfield (Erection of a single storey rear extension to provide additional living accommodation) – It was **RESOLVED** that No Comment be made.
- b) P20/03396/F – 8 Bissex Mead Emersons Green (Erection of a single storey rear extension to form additional living accommodation) – It was **RESOLVED** that **No Objection** be raised.
- c) P20/03472/RM – Parcel 21B Emersons Green East (Installation of service and access road on land at Parcel 21B. Reserved Matters application to be read in conjunction with PK04/1965/O (updated by PK15/4232/RVC)) – It was **RESOLVED** that **No Objection** be raised subject to the approval of the South Gloucestershire Council Transport Officer.

Members sought the views of the South Gloucestershire Council Transport Officer).
- c) P20/01845/PDR – 65 Elizabeth Way Mangotsfield (Demolition of existing conservatory. Erection of single storey rear extension to form additional living accommodation) – PERMIT (The Town Council did not Object).
