- b) P21/00369/TRE 23 Emerson Way Emersons Green (Works to crown lift 1no. Quercus Robur tree to 5.5m, reduce north and east elevations by 3m as well as south and west elevations by 1m, leaving a radial spread of 4m. Tree covered by KTPO 03/91 dated 29/07/1991) - PERMIT (The Town Council did

- not Object subject to the approval of the South Gloucestershire Council Tree Officer).
- c) P21/00371/TRE Tree East Of 16 Youngs Court Emersons Green (Works to 1 no. Oak tree to remove deadwood and thin living crown by 15%. Tree covered by Preservation Order KTPO 03/91 dated 29th July 1991) - PERMIT (The Town Council did not Object subject to the approval of the South Gloucestershire Council Tree Officer).
- d) P21/00557/F 72 Lulworth Crescent Downend (Erection of single storey side/rear extension to provide additional living accommodation) - PERMIT (The Town Council did not Object).
- e) P21/00862/PDR 44 Emerson Way Emersons Green (Erection of a single storey rear extension to form additional living accommodation) - PERMIT (The Town Council did not Object).

- a) P20/23276/F 27 Guest Avenue Emersons Green, Notification from South Gloucestershire Council that an appeal has been made to the Secretary of State against the refusal of planning permission.
- b) LI21/0924/STM Notification from South Gloucestershire Council that an application for a Mobile Street Trader license has been received from Café 2 U Bristol to trade throughout the South Gloucestershire area. The application is for the selling of snacks, hot and cold drinks between the hours of 8.00am until 14.30pm, Monday to Friday.
- c) South Gloucestershire Council Notice of Proposal for Traffic Order PT. 6865 - Henfield Road, Lyde Green. The Order is to introduce a Prohibition of Motor Vehicles restriction in part of Henfield Road (the length which extends from its junction with Elderflower Drive in a northerly direction for a distance of 455 metres), to prevent access from the Lyde Green / Emersons Green East housing development onto Westerleigh Road at the Henfield crossroads. The Order is required to prevent any adverse effect on the road being used as a short cut from the new major housing developments in Lyde Green/Emersons Green East. The closure will not be implemented until the new routes to the developments are available and will not apply to cyclists.
