2021.143. **Potential youth capital project (local youth venue)**

Consideration was given to potential to work collaboratively with a local community organisation with regard to a potential youth venue for development. A briefing document circulated by the Clerk was considered. There was no proposal put forward.

It was **Resolved** to look at turning the Town Council building into a youth venue, with the Town Council offices operating alongside.

- Councillor Palmer mentioned the Solar Together scheme which the Climate Emergency Working Group might like to look into. Councillor Bassett also suggested that there may be potential for installing solar panels at the Town Council offices.
- Councillor Palmer noted that Emersons Green Village Hall had experienced some issues with antisocial behaviour. They were installing new security guards and had employed a security guard temporarily. Some issues had also been reported at Lyde Green Community Centre concerning fire damage within the centre.
