Notification from South Gloucestershire Council that the order made by South Gloucestershire District Council on 16 September 2020 has been continued in force with the approval of the Secretary of State for Transport until 01 October 2022 or until such time as the works are completed, whichever is the earlier. The footpath will continue to be closed to foot passengers because of the likelihood of danger to the public consequent upon works to construct new dwellings and associated infrastructure and would have expired on 01 April 2022.
