161. Planning Applications

- a) P19/17990/F 7 Stockwell Close Downend (Erection of first floor side and front extension to form additional living accommodation) – It was RESOLVED that No Comment be made.
- b) P19/18031/RVC Downend Secondary School Westerleigh Road Downend (Removal of condition no.2 attached to planning permission PK18/2943/F to upgrade the floodlighting system)) – It was RESOLVED that No Objection be raised.
- c) P19/18589/PDR 5 Emet Grove Emersons Green (Erection of rear conservatory)
 It was RESOLVED that No Objection be raised.

162. Planning Decisions - Noted

a) PK17/4155/RM – Parcels 18 20A & 20B Emersons Green (Erection of 114 no. dwellings and construction of associated earthworks, roads, infrastructure, landscaping and parking. (Revised plans include land raising works across the site (the majority of the land raising work has already been carried out and is being

applied for retrospectively), additional land adjacent to Lyde Green Common within the site boundary (including proposed banks to accommodate land raising works and a proposed sewage pumping station), and setting back the building line of the houses a further 1-2m approximately from Lyde Green Common)) -PERMIT (The Town Council commented that Members had concerns the raising of the land may cause drainage issues and sought the approval of the South Gloucestershire Council Drainage Officer. Members also had concerns that waste materials may have been deposited without planning permission).

- b) P19/7455/F 29 Meadgate Emersons Green (Erection of 1no. attached dwelling with associated works) - REFUSE (The Town Council raised an Objection; Members had serious concerns that the proposed parking arrangements may not have been adequate and may have resulted in potential highway issues).
- c) P19/13218/F 60 Stockwell Drive Mangotsfield (Erection of a single storey side extension to form additional living accommodation) - PERMIT (The Town Council did not Object).
- d) P19/16072/F 104 Emerson Way Emersons Green (Erection of a single storey rear conservatory) – PERMIT (The Town Council did not Object).

- a) South Gloucestershire Council Notice of a Tree Preservation Order for an Oak tree adjacent to 33 Tunbridge Way Emersons Green. The order took effect, on a provisional basis, on 04 December 2019. It will continue on this basis for a further six months or until the order is confirmed by South Gloucestershire Council - Noted
- b) COM/19/1000/BOC 29 Rushy Way Emersons Green.
